## Creating A Safe Living Environment: Safety Adaptations for People with Dementia

**Safety Adaptations for Persons with Dementia:** For a person with memory loss, changes in perception, behavior, and abilities can lead to safety issues. Learn how each room in a home or care community can pose unique hazards, and how to create a calm and safe environment for the person with memory loss, including the use of adaptive equipment. An overview of the changes in abilities that affect daily living (ADLs), and recommendations that help caregivers succeed in various scenarios will also be covered.

### At the completion of the course, the participants will be able to:

- Recognize the changes associated with dementia that can lead to safety issues in a home or care facility
- Describe three modifications that can facilitate a safe environment for an individual with dementia
- Identify strategies that reduce wandering behaviors among individuals with dementia
- Describe strategies that can reduce agitation behaviors in people with dementia
