We are dedicated to providing quality care and support services to the thousands of residents of Orange County who are affected by Alzheimer's disease or other related dementia, and also partnering with local researchers to populate clinical trials to help find a cure.

Alzheimer's Orange County provides support to Orange County families and individuals through support groups, educational classes, social programs, helpline and care consultations, advocacy, adult day health services, and other memory support services.

Healthy Aging Center Acacia is a licensed Adult Day Center that serves the medical and social needs of individuals who are living at home, but need daytime assistance for their health needs. Our team is dedicated to improving the quality of life for frail older adults, persons with dementia or other disabilities and their families by providing expert, supportive care in an inviting and interactive setting.

At Healthy Aging Center Acacia, our team is made up of experienced, licensed, and certified professionals in social work, nursing, and therapy services—including physical, occupational, and speech therapy. We are proud of our ethnically diverse and multilingual staff, who are fluent in English, Spanish, Vietnamese, Korean, Chinese, and Tagalog, allowing us to better serve our community.

Our full-time team includes social workers, registered nurses, licensed vocational nurses, therapy aides, certified nursing assistants, and activity coordinators. Our program includes the expertise of consulting professionals, including a physician, physical therapist, occupational therapist, speech therapist, licensed clinical social worker, registered dietitian, and pharmacist.

Healthy Aging Center Acacia is prepared to meet the needs of our clients and families by providing respite care, counseling, referrals, daily socialization, and rehabilitation.

Answering the call

Our team received **4,134 Helpline calls** and conducted **1,103 Care Consultations** to provide answers, expert guidance and tailored support for each caller.



Improving understanding & care

15,109 people attended our educational classes on dementia, brain health, and healthy aging, gaining knowledge and skills to better support themselves and those they care for.



Bringing people together to create a community

2,796 attendees participated in support groups, meeting in-person, online, and in multiple languages to share experiences and solutions.

27,101 people served in 2024

Promoting active living and socialization

798 attendees participated in **Connect2Culture**, a program offering social activities for individuals in early to moderate stages of dementia and their care partners to connect and engage.



Engaging with healthcare providers

We reached **over 3,000 physicians**, sharing information about our services to expand awareness and improve dementia care in Orange County.



Community outreach for lasting impact

We engaged with **over 10,000 community members** and connected with elected representatives and local officials **183** times to raise awareness and advocate for those affected by dementia.



Enriching lives and providing essential respite

Our adult day center, Healthy Aging Center: Acacia, served **147 individuals** and provided **4,920 hours of therapy**, to help participants stay active, reduce costly care, and give families respite.
